RESEARCH PROFILE

I have 102 publications (Scopus), with over 50% (n=45) as first or senior author. I have a h-index of 26 (Scopus) and 28 (Google Scholar). SciVal analytics demonstrate my overall Field Weighted Citation Impact is 2.23, highlighting my work has received 123% more citations than similar authors. Approximately 32% of my publications are ranked in the top 10% most cited articles worldwide. I have supervised 6 PhD, 6 Master, and 8 Honours students to completion.

Evidence of Research Translation

Research that has resulted in the most significant change in practice has been concentrated on three major areas: Intranasal naloxone for heroin overdose, nursing handover, and communication skills training for nurses.

Intranasal naloxone for heroin overdose

- "A randomised trial of intranasal versus intramuscular naloxone in prehospital treatment for suspected opioid overdose", published in the *Medical Journal of Australia*, led to a series of studies investigating the effectiveness and safety of intranasal naloxone for heroin overdose.
- "Randomised controlled trial comparing the effectiveness and safety of intranasal and intramuscular naloxone for the treatment of suspected heroin overdose" was published in the highly ranked drug and alcohol journal Addiction and has been cited 116 times. The work led to the introduction of intranasal naloxone for heroin overdose in the prehospital setting in North America and for peer naloxone programs in numerous international sites.
- "Intranasal naloxone for the treatment of suspected heroin overdose", also published in Addiction, was a systematic review of evidence regarding the effectiveness of intranasal naloxone. These bodies of work have been acknowledged by several awards, and three competitive national grants: NHMRC Project Funding grant (\$789,979), NSW Health Drug and Alcohol Research Grant Program 2008/09 (\$49,000), and The William Buckland Foundation (\$15,000).
- The findings of the study "Attitudes of Australian heroin users to peer distribution of naloxone for heroin overdose: Perspectives on intranasal administration" supported the introduction of intranasal naloxone for peer naloxone programs in numerous international and Australian sites.
- The most recent study, "Effect of intranasal vs intramuscular naloxone in opioid overdose: a randomized clinical trial", has been published in the highly esteemed journal JAMA Network Open. A further study is currently underway at the Sydney Medically Supervised Injecting Clinic to compare concentrated intranasal naloxone with intramuscular naloxone, funded through NHMRC project funding.

Nursing Handover

- Arising from concerns at a major metropolitan health service in Melbourne, Victoria, the preliminary study "Examination of current handover practice: evidence to support changing the ritual" provided evidence of the problem relating to variance and lack of patient involvement in nursing handover.
- In the same organisation, a pre/post study identified improvements in nursing care and documentation after the introduction of bedside handover in a study titled "Bedside Handover Enhances Completion of Nursing Care and Documentation."
- Two individual studies published in International Journal of Nursing Practice, "Bedside nursing handover: patients' opinions" and "Towards patient-centred care: perspectives of nurses and midwives regarding shift-to-shift bedside handover", revealed positive attitudes regarding bedside handover from the consumers' and nurses' perspective.
- Supported by a nationally competitive grant, (Nurses Board of Victoria Legacy Limited Grant) a bedside handover model was developed for the emergency department in the study titled "Developing a framework for nursing handover in the emergency department: an individualised and systematic approach".
- The study titled "Impact of a modified nursing handover model for improving nursing care and documentation in the emergency department: A pre- and post-implementation study" found improvement in nursing care and documentation after the introduction of the new handover model.
- Positive attitudes regarding the bedside handover model were found and subsequently reported in "Attitudes of emergency department patients about handover at the bedside". This piece of work led to the recommendation that nursing handover be conducted at the bedside within the major metropolitan health service in Melbourne, Victoria.

Communications Skills Training

- Arising from concerns about the method of teaching communication skills to registered nurses which is modelled on medical education, I have embarked on a new area of research. In the preliminary study which I led, "The effectiveness of training interventions on nurses' communication skills: A systematic review", we determined that there is a scarcity of evidence for the effectiveness of communication skills training programs for nurses, particularly in general medical/surgical ward settings.
- In a qualitative study, "Challenges for nurses when communicating with people who have life-limiting illness and their families: A focus group study", we identified that nurses lack confidence and a comprehensive understanding of the full repertoire of skills that can be used when communicating with individuals with life limiting illness. In response to these findings, a multidisciplinary team developed a nurse-specific training program the Communication Skills Training program for Nurses.
- In the study "Responding to nurses' communication challenges: evaluating a blended learning program for communication knowledge and skills for nurses", published in *Patient Education and Counseling*, we were able to show an improvement in knowledge and confidence for nurses' communication.
- Building from this research, I have recently led the preparation of a discussion paper, currently in draft form in *Patient Education and Counseling*, that summarises the challenges with teaching nurses communication skills, "Communication Skills Training for Nurses: Is It Time For A Standardised Nursing Model?".
- There is current conversation within the Special Interest Group (Healthcare Communication in Nursing) of EACH (International Association for Communication in Healthcare) regarding training needs for nurses. An Australian EACH sub-group, of which I am a member are currently writing a second discussion paper titled "A conversation starter: Considerations for research, teaching, policy and practice in communication in clinical practice in Australia and New Zealand."
