#### PERSONAL STATEMENT

As a Senior Measurement Scientist, I have thirty years of experience with the NBME in the field of clinical skills assessment. I lead a dynamic team which includes professionals with diverse life stories, abilities, and experiences. The diversity of my team has contributed significantly to our effectiveness.

Early in my NBME career, I led the team that conceived, developed, and implemented the test development and training material for the Step 2 Clinical Skills Exam. When Step 2 CS was adopted by USMLE in 2004, it became the first assessment of clinical skills to be included as a part of licensure since Dr. Edithe Levit was NBME President in the early 1960s.

The implementation of a clinical skills exam created a need for professional Standardized Patient trainers. In 1990, I co-founded, together with the Medical Council of Canada, a group of standardized patient trainers which in 1992 became the Association of Standardized Patient Educators (ASPE). To this day, ASPE is the global leader in human simulation education. I was gratified that ASPE recognized my contribution when it awarded me their highest honor, the Standardized Patient Educator Award, in 2005.

Since Step 2 CS was adopted as a part of licensure, I have turned my focus to creating and testing communication assessment tools which utilize a sampling approach to present communication challenges that are evaluated by crowdsourced raters. This innovative groundbreaking work, the Video-based Communication Assessment (VCA), received a US patent in 2019. As such, VCA is one of only three patents granted to the NBME in the 108 years since its founding. I am excited to continue to work toward the implementation of VCA. It consistently ranks among the highest goals of NBME.

Apart from VCA, I manage a second significant project, the Patient Video Prompt (PVP). The PVP is intended to assess communication skills as part of licensure. The PVP assessment will present communication challenges via vignettes to examinees and rely on a machine scoring protocol.

In addition to my milestone achievements, I am the Co-Director of the popular FAME (Fundamentals of Medical Education) course. For over 15 years, the FAME course has allowed me the opportunity to recruit fellow course leaders and to mentor academic leaders in medical education from over 100 medical schools around the world.

In the medical education community, I am widely recognized as a leader in the field of communications assessment. My excellent relationships with academics across the world are a significant intangible asset that benefits NBME in our research, affiliations, and test development. Additionally, these relationships keep me on the leading edge of emerging trends in measurement and in medical education.

Two examples of these relationships paying dividends are the research work NBME presently is conducting with the University of Washington (for VCA) and with the University of Massachusetts (VCA applied to weight loss).

I seek to continue the work of developing innovative assessments that enhance the quality of patient care.
